## Scholarship Program Application

The purpose of the Franklin Electric Key Dealer Scholarship Program, (the “Program”) is to provide financial assistance to defray the cost of education, to qualified students who are an employee or a relation of an employee who is employed by an enrolled Franklin Electric Key Dealer. Applicant must be pursuing a degree or training in a higher educational degree/certificate at an accredited post-secondary school. All funds awarded under the Program will be paid by the Franklin Electric Key Dealer Program.

### Definitions

Applicant: The person applying for the Program

Relation: Spouse, child, grandchild, or legal guardian of employee

Employee: An active and full-time employee of the company who is currently enrolled in the Franklin Electric Key Dealer Program and who has been employed by such company for at least two years

Recipient: The Applicant chosen to receive the program funds

### Scholarship

The Program is a one-time award to the most outstanding applicant(s) meeting the eligibility requirements. Up to five (5) scholarships of \$2,000 each will be available each year, awarded directly to an accredited post-secondary school such as a university, college, technical/vocation college, community college, and online college programs. There is no restriction on the use of the scholarship fund.

### Eligibility Requirements

The Program is open to an employee or a relation of an employee who is employed by a company which is an enrolled Franklin Electric Key Dealer company. Applicant must be a U.S or Canadian Citizen. He/she must have plans to, and actually, pursue a higher educational degree/certificate at an accredited post-secondary school.



## Applying

Applicant must complete and return this Application no later than April 1st of the given year. Neither the Franklin Electric Key Dealer Scholarship Program nor Franklin Electric Company Inc. are responsible for untimely submissions, regardless of the cause or reason for the untimeliness.

In addition to this Application, an Applicant must submit:

1. A description of proposed curriculum of study (i.e., list of courses that have been or will be taken during the course of the pursued curriculum)
2. A letter of recommendation
3. One- to two-page essay of educational plans and career objective
4. One-page resume that includes all schools, colleges and universities attended; dates, major/fields of study, grade-point average, degrees received, work experience, and extracurricular activities; and,
5. Official Transcript from high school and any post-secondary institutions.

## Incomplete applications will not be considered.

## Award Criteria and Process

Franklin Electric Key Dealer Program will appoint a Selection Committee comprised of area teachers, professors, and/or other professionals. The Committee will review the applications and select up to five (5) Recipients, considering all materials provided.

Applicants will be notified by the end of June informing them if they have been selected or not.

Payments will be made in full on August 1st. Recipient must provide evidence of enrollment at the institution before the payment will be made. Checks are mailed to each recipient's enrolled institution, made payable to the institution for application to the Recipient's tuition bill.

## Recipient Responsibility

Failure to submit proof of enrollment may result in Recipient's forfeiture of payment under the Program. Franklin Electric Key Dealer Program reserves the right to cease making payment under the Program if Recipient fails to meet these requirements.
